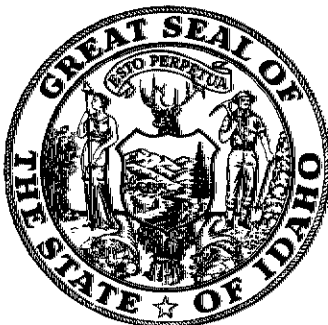

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being all the shareholders, directors and officers of Paulmark, Inc., and Sudon Corporation, pursuant to that Corporate Resolution of the Shareholders of Paulmark, Inc., and Sudon Corporation, do hereby submit these Articles of Merger as follows:

1. Paulmark, Inc., and Sudon Corporation are hereby merged, with Sudon Corporation being the surviving corporation, and with the name of Sudon Corporation being changed to Paulmark, Inc.

2. As Mark Villano and Paul Villano own all of the issued and outstanding shares of Paulmark, Inc., being 80 shares and 20 shares, respectively; and Paulmark, Inc., owns all the issued and outstanding shares of Sudon Corporation, being 2 shares; by stock conversion, Mark Villano will hereafter own 80 shares of common stock of Sudon Corporation, and Paul Villano will own 20 shares of common stock of Sudon Corporation.

3. The above referenced shareholders have voted unanimously in approval of this merger, as set forth in the Corporate Resolution of the Shareholders of Paulmark, Inc., and Sudon Corporation.

Changes in the Articles of Incorporation of the surviving corporations, Sudon Corporation, are only that Sudon Corporation shall be hereafter known as Paulmark, Inc. Further, the surviving corporation shall operate according to the By-Laws of the former Paulmark, Inc.
