KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned, citizens of the United States of America, each being over the age of eighteen (18) years, do hereby associate ourselves together for the purpose of forming a non-profit corporation under and pursuant to the provisions of the laws of the State of Idaho, for the purposes expressed in the following articles, and do hereby adopt the following Articles of Incorporation:

ARTICLE I.

NAME OF THE CORPORATION

The name of the corporation shall be BOVILL-DEARY JUNIOR MISS SCHOLARSHIP PROGRAM, INC.

ARTICLE II.

TERM

The corporation shall have perpetual existence.

ARTICLE III.

PURPOSES

The corporation is organized for the following general and specific purposes:

Section I.

The purposes for which said corporation is formed is to plan, coordinate, organize and produce a pageant for competition within the structure and guidelines set by the National Junior Miss Competition, in the Bovill-Deary, Idaho area.

Section II.

To solicit for donations from individuals as well as businesses, organize and hold fund raisers to establish funds to cover production costs of the pageant, along with earmarking certain amounts of funds for scholarships and/or awards, and perform all things necessary to promote the carrying on of

the business of the corporation.

ARTICLE IV.

PROVISIONS FOR THE REGULATION OF  
INTERNAL AFFAIRS OF THE CORPORATION

Section I.

MEETINGS OF THE OFFICERS

The meetings of the Officers of the corporation, whether regular or special, may be held either within or without the State of Idaho as may be determined by the Officers by at least two-thirds of the Officers of the corporation. Notice of such meetings shall be given as prescribed by the Officers.

Section II.

BY-LAWS OF THE CORPORATION

The Officers of the corporation shall have the power to adopt By-Laws for the corporation, to amend the same from time to time at regular or special meetings of the Officers. The amendment of By-Laws shall require affirmative vote of two-thirds of the Officers present in order to be adopted.

Section III.

BOOKS AND RECORDS OF THE CORPORATION

The corporation shall keep such books and records as are reasonably necessary to the conduct of its affairs at each officer shall maintain books pertinent to her office; or other such places as the Officers may direct.

Section IV.

REGISTERED AGENT/REGISTERED OFFICE

The registered agent of the corporation is Shelly Cannon,  
Route 1 - Box 166, Deary, Idaho 83823.

Section V.

AMENDMENT OF THE ARTICLES OF INCORPORATION

The Articles of Incorporation may be amended by the membership who have the right to vote at any regular or special meeting of the Officers, provided that a quorum is present. A two-thirds majority of votes shall be required to adopt any such amendment, provided that notice of the proposed change shall have been given not less than five (5) days prior to such meeting.

ARTICLE V.

OFFICERS

Section I.

INITIAL OFFICERS

The initial Officers of the corporation shall consist of the following. There shall be no Board of Directors.

Until their successors are elected and qualified, the above-named officers shall serve their positions.

ARTICLE VI.

PRINCIPLE PLACE OF BUSINESS

The principle place of business shall be Deary High School

may better serve the needs required by the corporation to produce the annual  
pageant.
