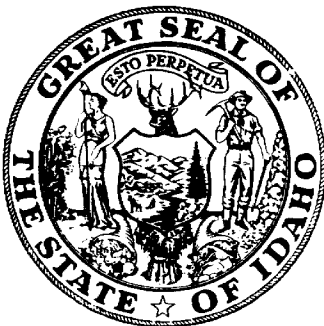

Articles of Incorporation for such corporation:

FIRST: The name of the corporation is J & A ENTERPRISES, INC.

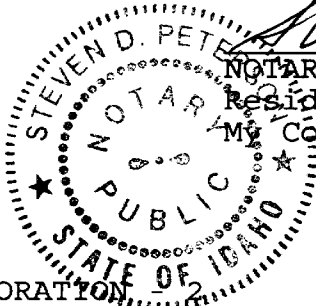
