KNOW ALL MEN BY THESE PRESENTS: That we, Howard Nafziger, President, Chas. C. Banks, Vice-President, Betty Banks, Second Vice-President and Doris Nafziger, Secretary-Treasurer, the same being a majority of the Board of Directors of Nafziger-Banks, Inc., formed and existing under the laws of the State of Idaho, do hereby certify:

That a special meeting of the stockholders of said corporation was held at the office of the Nafziger-Banks, Inc., Nampa, Idaho, on the 6th day of January, 1948, at 8:00 o'clock P. M., after thirty days notice of meeting, as prescribed by law; that all the stockholders of said corporation were then and there present at said meeting in person, and signed waiver of notice of meeting; that at said meeting a resolution that the Capital Stock be increased from \$15,000.00 to \$50,000.00 was regularly proposed, voted upon and adopted by the unanimous vote of all the stockholders of said corporation; That the following is a true copy of said resolution, to-wit:

"BE IT RESOLVED, That the authorized Capital Stock of \$15,000.00, divided into 15,000 shares of common stock at a par value of \$1.00 per share, be increased to \$50,000.00, divided

into 50,000 shares of common stock at a par value of \$1.00 per share.


"BE IT FURTHER RESOLVED, That the proper officers of this corporation be, and they hereby are, authorized and empowered to make such certificates and payments, and take such other action as may be necessary in order to effect the increase of the Capital Stock of this corporation, provided for by the foregoing resolution."


