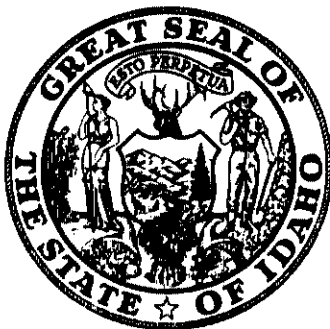
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. NAME: The name of the corporation is The Creative Center for Children, Inc.
2. DURATION: The period of it's duration is perpetual.
3. PROFIT: This is a non-profit corporation.
4. PURPOSES: The purpose or purposes for which the corporation is organized is to provide child care and pre-school services and for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Nonprofit Corporation Act.
5. MEMBERS: The corporation shall have no members.
6. DISSOLUTION: Upon dissolution of the corporation the assets net of any liabilities will be distributed to another qualified non-profit organization to be determined by the board of directors.
7. BUSINESS AFFAIRS: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the corporation's By-laws.
