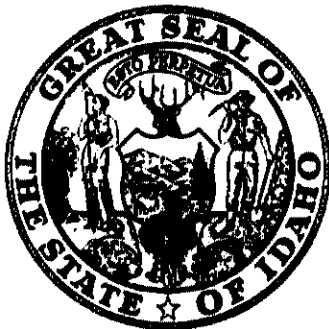
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

KNEELAND, KORB, COLLIER, LEGG, & HAUKAAS, P.A.

The undersigned, acting as incorporators under the provisions of the Idaho Business Corporation Act and the Idaho Professional Service Corporation Act, adopt the following Articles of Incorporation:

1. NAME. The name of the corporation is:  
Kneeland, Korb, Collier, Legg, & Haukaas, P.A.
2. DURATION. The period of its duration is perpetual.
3. PURPOSE. The purpose for which the corporation is organized is the transaction of professional legal services.
4. STOCK. The corporation shall have the authority to issue ten thousand (10,000) shares of capital stock, all of one (1) class, ONE DOLLAR (\$1.00) par value.






