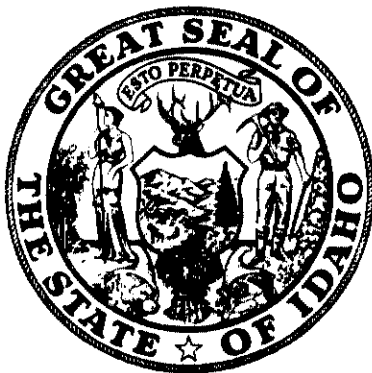

A meeting was held Thursday, February 13, 1992, in which a quorum attended. Purpose of the meeting was to amend Article 2 of the Multiple Listing Service of the Bonner County Association of Realtors, Inc. Articles of Corporation to read as follows: APR 9 22

A Multiple Listing Service is a profit making organization and is a means by which authorized Participants make blanket unilateral offers of subagency to other Participants; by which the Participant may, if permitted under the Rules and Regulations, make offers of compensation to buyer agents; by which information is accumulated and disseminated to enable authorized Participants to prepare appraisals and other valuations of real property; by which Participants engaging in real estate appraisal contribute to common databases; and is a facility for the orderly correlation and dissemination of listings information among Participants so that they may better service their clients and the public.

And, to add an ARTICLE VI which reads as follows:

The Multiple Listing Service of the Bonner County Association of Realtors, Inc. is authorized to issue 500 shares of stock valued at \$10 per share.

The above amendments were voted on and approved by a majority vote.
