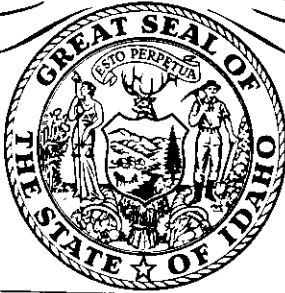

ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
THUNDERBIRD SALES OF IDAHO, INC.

The undersigned, W. HAGUE ELLIS and SUE J. ELLIS, President and Secretary, respectively, of THUNDERBIRD SALES OF IDAHO, INC., a corporation duly organized and existing under the laws of the State of Idaho, hereby certify and declare as follows:

That a special meeting of stockholders of THUNDERBIRD SALES OF IDAHO, INC. was duly called, convened and held at Salt Lake City, Utah, on the 30th day of June, 1967, at 1:00 o'clock P.M.

That at said meeting the following resolutions amending the Articles of Incorporation were duly adopted:

RESOLVED: That the Articles of Incorporation of THUNDERBIRD SALES OF IDAHO, INC. be and the same are hereby amended to read as follows:

ARTICLE I

The name of the corporation herein incorporated shall be

THUNDERBIRD AVIATION CORPORATION.

BE IT FURTHER RESOLVED: That the President and Secretary of the corporation are hereby authorized to execute Articles of Amendment in accordance with the laws of the State of Idaho and to cause the same to be filed with the Secretary of State of the State of Idaho and to do all other things necessary and proper to accomplish the foregoing amendment.

At the time the said special meeting of the stockholders was held, there were 5,000 shares of common capital stock of the corporation outstanding; there were present and represented at the meeting in person 5,000 shares of common capital stock of the corporation and 5,000 shares of the common capital stock represented at the meeting voted in favor of the adoption of the foregoing resolutions.
