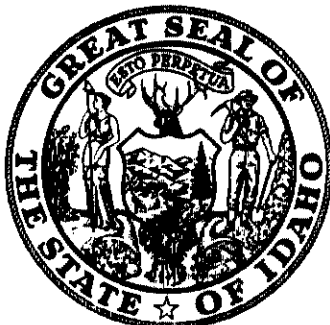
CERTIFICATE OF INCORPORATION OF

That the undersigned, being a bona fide United States citizen, over the age of twenty-one years, does, under and in pursuant to the general corporation laws of the State of Idaho, hereby organize, constitute and associates ourselves, and such other persons as may hereafter become associated with us, into a body politic and corporate, and to that end execute the following **ARTICLES OF INCORPORATION** and do hereby set forth and declare as follows:

I

That the name of the corporation is, and shall be **BARLOWS CONTRACTORS, INC.**

II

This corporation shall have perpetual existence.

III

That the principle office of this corporation shall be 530 N. Arthur, Suite #2, Pocatello, Idaho 83201, and that other offices for the transaction of the business of corporation shall be established by the initial registered agent from time to time, both within and outside the State of Idaho.

IV

The purpose for which the corporation is formed are as follows:

- (a) To purchase, own, sell, lease, improve, equip, operate and engage in the real estate rental, development and sales.*
- (b) To purchase, sell, hold, acquire, own, mortgage, transfer, lease, exchange, trade or dispose of all types of real estate and personal property for any of the purposes aforesaid.*
- (c) To purchase, sell, hold, acquire, own, mortgage, hypothecate, convey, improve, transfer, lease, exchange, trade and dispose of real and personal property.*
- (d) To invest the capital of the company for any of the purposes aforesaid and in building or otherwise improving or adding to the market value of the land or other properties from time to time acquired by the company.*
- (e) In general, but in connection with the foregoing, the company may carry on any other business, and exercise all the powers conferred by the laws of the State of Idaho, upon corporations formed under the laws*

of specific powers shall not be held to limit or restrict in any manner the general powers of the company.

V

The corporate powers, business and property of the company shall be exercised, conducted, and controlled by the incorporator.

VI

The amount of the said capital stock of this corporation shall be Fifty Thousand Dollars (\$50,000.00), divided into Five Hundred (500) shares of the par value of the One Hundred Dollars (\$100.00) per share.

VII

The amount of the said capital stock, i.e., Five Hundred Shares (500) shall be non-assessable.
