RE: U.S. Bancorp Advisors, LLC. - Use of the Word "Bancorp" in Company Name in Idaho

Dear Ms. Grossnickle:

The Idaho Department of Finance (Department) received your email on April 15, 2025, requesting a waiver required by the Idaho Secretary of State in order to register the business name "U.S. Bancorp Advisors, LLC" in the state of Idaho. As you indicated in the request form, "U.S. Bancorp Advisors, LLC." serves as the securities broker-dealer or an investment adviser in collaboration with affiliates US Bank and USBA Insurance Services. We understand that U.S. Bancorp Advisors, LLC will not operate in Idaho as a depository institution or conduct the business of banking.

Idaho Code § 26-1202 generally prohibits persons from advertising or transacting business in this state under a name or title containing the word "bank," "banker," or a word or words of similar import, unless the person holds a banking charter. The Director of the Department may grant a waiver to allow the use the word "bancorp," or words of similar import in certain circumstances. The waiver may be granted if:

- (a) The person is not engaged in banking or trust business;
- (b) The name or title used is not likely to deceive or mislead an individual to believe that the person is engaged in banking or trust business;
- (c) The name or title, or a name or title similar to it, is not already used by another person doing business in this state; and
- (d) The name or title does not suggest or imply that the person is engaged in unlawful conduct.

Based and conditioned on the information you have provided, it appears that the four factors set forth above, which allow the Director to grant a waiver to use the word "Bancorp" in your company's name in Idaho, exist under the facts you have presented to us. I hereby grant a waiver to you to use
