1 ARTICLES OF INCORPORATION
2 OF

4 (A Professional Corporation)

5 I, the undersigned, a natural person over the age of
6 eighteen years and legally authorized to render legal services
7 within the State of Idaho, do hereby form a professional cor-
8 poration under the laws of the State of Idaho, as contained in
9 Idaho Business Corporation Act and to that end do hereby
10 certify:

11 ARTICLE I

12 NAME

13 The name of the corporation shall be Donald E.
14 Sonius, D.D.S., P.A.

15 ARTICLE II

16 PURPOSES AND POWERS

17 The purposes for which the corporation is organized
18 are:

19 A. To engage generally in the professional practice
20 of dentistry as a professional corporation as the same is now
21 or hereafter defined by statute, rule and regulation;

22 B. To invest funds in real property, personal pro-
23 perty, mortgages, stocks, bonds or any other type of invest-
24 ments and to own or lease real or personal property necessary
25 for the rendering of such professional services.

1 C. To engage in such other businesses or professions
2 as may be authorized or permitted by the Professional Service
3 Corporation Act and to the extent not inconsistent with the
4 foregoing as may be permitted by the Idaho Business Corporation
5 Act.

6 ARTICLE III

7 DURATION

8 The period of duration of the corporation shall be
9 perpetual.

10 ARTICLE IV

11 REGISTERED OFFICE

12 The registered office of said corporation in the
13 State of Idaho shall be located at 155 Blue Lakes Blvd. North,
14 Twin Falls, Idaho, in the County of Twin Falls; the post office
15 address of the registered office of said corporation in the
16 State of Idaho, County of Twin Falls, shall be 155 Blue Lakes
17 Blvd. North, Twin Falls, Idaho. Donald E. Sonius, D.D.S. shall
18 be the registered agent at the address set forth above.

19 ARTICLE V

20 CORPORATE STOCK

21 The aggregate number of shares which the corporation
22 shall have authority to issue is 5,000 all of which shall have
23 a par value of \$1.00 per share.

The business of the corporation shall be managed by a
board of at least three (3) directors, except that if all of
the shares of the corporation are owned beneficially and of
record by either one (1) or two (2) stockholders, the number of
directors may be less than three (3) but not less than the
number of stockholders. Directors need not be shareholders. A
director shall hold office for the term for which he was named
or elected and until his successor is elected and qualified.

There shall be one (1) director on the initial Board
and he shall be Donald E. Sonius, D.D.S., who shall serve as a
director until his successor is elected and qualified.

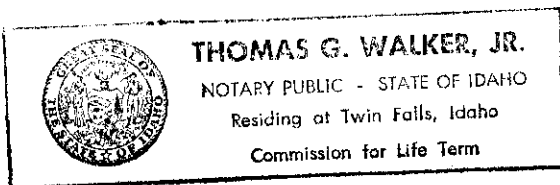
