The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is American Pennant Corporation.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000,000 shares, such shares to consist of one class only and shall have a par value of One Dollar (\$1.00) per share.

The aggregate par value shall be \$1,000,000.

FIFTH: The address of the initial registered office of the corporation is 301 Cedar Avenue, P.O. Box 8729, Moscow, Idaho 83843, and the name of its initial registered agent at such address is Lance S. Haserot.
