Re: Use of "bank" in company name

Dear Ms. Langford:

The Idaho Department of Finance (Department) has received and reviewed your email to Stephanie Seeds dated July 13, 2012. In that email, you requested that the Department give permission for use of the name "Community & Southern Bank" in the state of Idaho.

We understand that Community & Southern Bank (CSB) is an FDIC-insured institution charted by the State of Georgia on January 29, 2010. We further understand that CSB does not intend to conduct a banking business in Idaho, but intends to conduct a consumer and commercial lending business in Idaho. With respect to such business, we understand that CSB will offer consumer loans for the purchase of, or the refinancing of loans for, yachts, aircraft and luxury RVs through a network of correspondent lenders in Idaho. In addition, it appears that CSB has agreements in place with the correspondent lenders with local representation in Idaho, which will facilitate the transactions on behalf of CSB.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Idaho Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirements of the law. Rather, the Department is offering "no objection" to the company's use in Idaho of the name "Community & Southern Bank." Under the circumstances discussed above, we do not believe the company's proposed use of the name "Community & Southern Bank" in Idaho is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.
