The undersigned, BRAD F. TRACY, being a person of legal age, does hereby form a domestic corporation under and pursuant to the laws of the State of Idaho, and does hereby certify:

**FIRST:** The name of this Corporation shall be CONCRETE STRUCTURES CO., INC.

**SECOND:** This Corporation is formed for the purpose of transacting any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.
