The undersigned, acting as the incorporator of a corporation under the provisions of the Idaho Non-profit Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

NAME AND LOCATION

The name of the corporation shall be Black Bear Property Owner's Association, Inc.

ARTICLE TWO

NON-PROFIT STATUS

This corporation shall be a non-profit corporation organized pursuant to Sections 30-301, et seq. of the Idaho Code.

ARTICLE THREE

DURATION

The period of this corporation shall be perpetual.

ARTICLE FOUR

PURPOSES

The purposes for which this corporation is organized are as follows:

(A) To perform the functions and provide service as set forth in the Declaration of Protective Covenants, Conditions and Restrictions for Black Bear Subdivision, located in Adams County, Idaho, hereinafter referred to as the "Declaration."

(B) To exercise all other power allowed by law and not inconsistent with the limiting language contained hereinbelow;

(C) This corporation is organized and shall be operated exclusively for the above-stated purposes and for other non-profit purposes. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (A) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of

1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

(D) Upon dissolution of the corporation, its assets shall be distributed in accordance with the corporation's exempt, non-profit status, and shall not be distributed to or inure to the private benefit of its members.

ARTICLE FIVE

NON-STOCK CORPORATION

This corporation shall be non-stock, and no dividends or pecuniary profits shall be declared or paid to its members.

ARTICLE SIX

MEMBERS

The corporation shall have two (2) classes of membership in accordance with the Declaration and Corporate Bylaws.

ARTICLE SEVEN

REGISTERED AGENT AND OFFICE

The street and mailing address of the initial registered office of the corporation shall be 1963 South Springbrook Lane, Boise, Idaho, 83706. The name of the corporation's initial registered agent at such address is Normal Del Geddes.

ARTICLE EIGHT

DIRECTORS

The business of this association shall be managed by a Board of Directors of not less than ~~one (1) nor more than~~ ^{three} three (3) directors who shall be chosen by the members. The number, qualification, terms of office, manner of election, powers and duties of such directors shall be such as may be prescribed by law, these articles and such Bylaws as may from time to time be in force. The number of directors constituting the initial board of directors of the corporation is one, and the name and address of the person who shall serve as initial director until the first meeting of the membership, is as follows:
