

Articles of Incorporation

of

Sidney Stevens Implement Company.

We the undersigned, residents of Ogden, Utah whose full names are:-

Sidney Stevens,

M. J. Stevens,

Sidney O. Stevens,

Frank J. Stevens, and

C. Henry Stevens,

being desirous of associating ourselves together for the purpose of establishing, maintaining and conducting the business of manufacturing, buying and selling vehicles, machinery, agricultural implements, hardware, and building material, and other lines of goods that may be deemed advisable, on commission or otherwise, and of holding property, real or personal, and of incorporating for these purposes under and in pursuance of the laws of the State of Utah, do hereby adopt the following articles of Agreement:-

1.

The name and style of the Corporation shall be "SIDNEY STEVENS IMPLEMENT COMPANY" and shall continue for the term of Fifty years unless sooner dissolved according to law.

11.

The business or pursuit of the Corporation shall be to manufacture, buy and sell vehicles, machinery, agricultural implements, hardware and building material, and other lines of goods that may be deemed advisable, on commission or otherwise, also to purchase all lease, acquire, use and hold such real and personal property as may be necessary and convenient and to enable the corporation to collect debts, judgments or decrees in its favor and to carry on and conduct its business and to sell or otherwise dispose of any or all property at pleasure.

111.

The principle place of business and general office of the corporation shall be at Ogden, in the County of Weber and State of Utah, with branches at such other points as may be convenient and desirable.

2.

IV.

The officers of the corporation shall consist of a Board of Five Directors, a President, a Vice-President, a Secretary and a Treasurer ; each of whom to be eligible to election must be the owner of at least one share of the capital stock, as shown by the books of the corporation. Three members of the Board of Directors shall be necessary to form a quorum and to be authorized to transact the business and exercise the corporate powers of the Corporation.

V.

Within ten days after the election of a Board of Directors they shall hold a Directors meeting to elect a President, a Vice-President, a Secretary and Treasurer . The President and Vice-President shall be chosen and elected from their own number, but the secretary and Treasurer may be elected either from the Board of Directors or from the Stock holders, in the discretion of the Board, and <sup>in</sup> the discretion of the Board , the same person may hold both the office of Secretary and ~~the~~ office Treasurer.

V1.

There shall be held an annual meeting of the Stockholders at the general office of the Corporation at Ogden, County of Weber and State of Utah, on the second ~~and~~ Monday in February of each year , commencing with the year 1897, at such hour as the President or Board of Directors may determine, for the purpose of receiving the report of the Board of Directors of the business of the corporation for the year last passed and for the election of a Board of Directors for the ensuing year , and for the transaction of such other business as may properly be brought before the meeting.

The Stockholders shall be empowered ~~at~~ at any general annual meeting to appoint an auditing committee to audit the accounts of the company and report their findings in detail statement to the stockholders at a meeting held for that purpose .

The Board of directors may direct the calling of special meetings of the stockholders , at such times as they may deem necessary.

At all of said meetings of the Stockholders, whether annual or special, representation of a majority of the Capital Stock shall be necessary for the transaction of business, and no business, except to adjourn or to adjourn to a specified date, shall be transacted at any meeting of the Stockholders unless a majority of the Stock is represented.

The officers of the corporation shall be elected by ballot, and the persons receiving a majority of the votes cast shall be deemed and declared duly elected. Each stockholder shall be entitled to as many votes as he holds shares of capital stock, and representation by proxy, duly appointed, shall be allowed at all meetings of the Stockholders, whether annual or special.

Failure to hold any annual or special meetings of the stockholders on that day, or at the time appointed for the same, shall not forfeit or in any way interfere with the corporate rights acquired under this agreement, but any such meeting may be held at any subsequent time upon giving twenty-one days notice thereof by publication in a daily news paper, published in Ogden, Utah.

The Secretary shall, or in case of his failure, any other officer of said corporation may give twenty-one days notice of all annual or special stockholders meetings by publication as aforesaid.

The notice must specify the purpose for which any special meeting is called.

Notice of any annual or special meeting may be served by the Secretary or other officer as the case may be, by delivering a copy thereof to each stockholder of said corporation, personally or by depositing copies thereof in the Post Office in Ogden, Utah with the postage prepaid thereon, at least twenty one days prior to the date of any such meetings, addressed to the several addresses of the stockholders, which shall have the same effect as the publication as aforesaid.

## VII.

The term of office of all officers, except when a vacancy is filled and except as provided in Article Eight, shall be one year and until their successors are elected and qualified.

## VIII.

Until the annual meeting of the Stockholders on the second Monday in February 1897 and the election and qualification of officers thereafter, the following named persons shall be

Directors of the corporation, to-wit:- Sidney Stevens, M. J. Stevens, Sidney O Stevens, Frank J. Stevens and C. Henry Stevens.

And the said Sidney Stevens shall be President, the said Sidney O. Stevens shall be Vice-President; the said C. ~~Henry~~ Stevens shall be Secretary and the said Frank J. Stevens shall be Treasurer.

## IX.

The Board of <sup>directors</sup> may fill vacancies occurring <sup>in</sup> the Board or in any of the offices of the corporation until the next annual meeting for the election of officers.

## X.

The Board of Directors shall have the General Management of the business of the corporation ; they may also appoint such other officers as the necessities of the business may require , and may by a three fifths vote of the whole Board adopt such by-laws for the regulation of the business of the corporation as may be necessary and may, by meeting called for that purpose alter and amend the same.

## XI.

Any officer of the Corporation may be removed for conduct prejudicial to the interests of the same by a two thirds vote of the stockholders.

## XII.

Any officer of the corporation may resign his office by giving the Board of Directors at least thirty days notice in writing before the same is to take effect, but the same may be accepted on shorter notice.

## XIII.

The private property of the stockholders shall not be liable for the debts or obligations of the corporation .

## XIV.

These articles of agreement may be altered or amended at a meeting of the stockholders called for that purpose as provided by the laws of the State of Utah.

## XV.

The amount of the capital stock of the corporation shall be three hundred thousand (\$300,000.00) dollars , divided into three thousand shares of par value of One Hundred (\$100.00) Dollars each.

## XVI.

The amount of the capital stock subscribed by the corporators parties hereto , is as follows: -

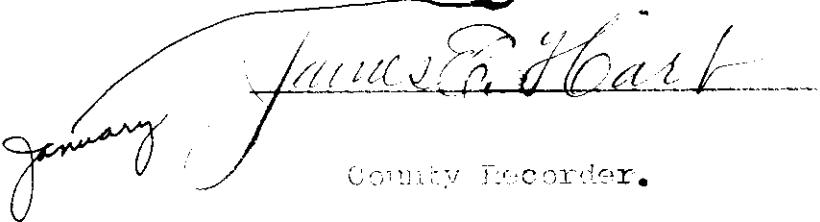
