RESTATED ARTICLES OF INCORPORATION OF INTERMOUNTAIN EXCAVATION, INC. FORMERLY KNOWN AS LA QUINTA EXCAVATION, INC.

These Restated Articles of Incorporation are signed in duplicate, verified and acknowledged by the President and Secretary of this Corporation on behalf of the shareholders of the corporation for the purpose of Restating the Articles of Incorporation of this corporation to change the name of the corporation from La Quinta Excavation, Inc. to Intermountain Excavation, Inc. and replacing the original Articles of Incorporation adopted on October 23, 1995, as provided under Idaho Code Section 30-1-64.

The shareholders of the corporation met on the 24th day of March, 1996, to consider the amending and restating of the Articles of Incorporation to change the name of the corporation from La Quinta Excavation, Inc. to Intermountain Excavation, Inc.


