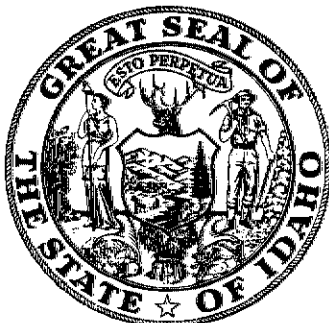

RESTATED ARTICLES OF INCORPORATION
OF

These Restated Articles of Incorporation are signed in duplicate, verified and acknowledged by the President and Secretary of this Corporation on behalf of the shareholders of the corporation for the purpose of Restating the Articles of Incorporation of this corporation to change the name of the corporation from La Quinta Excavation, Inc. to Intermountain Excavation, Inc. and replacing the original Articles of Incorporation adopted on October 23, 1995, as provided under Idaho Code Section 30-1-64.

The shareholders of the corporation met on the 24th day of March, 1996, to consider the amending and restating of the Articles of Incorporation to change the name of the corporation from La Quinta Excavation, Inc. to Intermountain Excavation, Inc.

There is only one class of stock entitled to vote on the amendment. There have been 200 shares of corporate stock issued.

ARTICLE I

The name of the corporation is Intermountain Excavation, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which said corporation is organized are: The transaction of any lawful business for which

corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is: One Million (1,000,000) shares of voting common with a par value of One Dollar (\$1.00) per share.

ARTICLE V

Provisions granting preemptive rights are: As contained in Idaho Code Section 30-1-26 and as that section reads this date.

ARTICLE VI

Provisions for the regulation of the internal affairs of the corporation are: The incorporators elect not to include such provisions in these Articles.

ARTICLE VII

The address of the initial registered office of the corporation is Box 158, Kamiah, Idaho 83536, and the name of its initial registered agent at such address is Paul Duclercque.

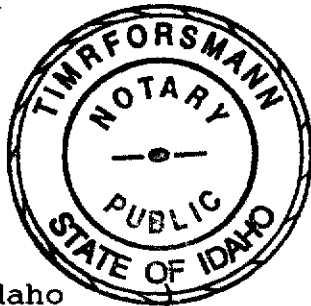

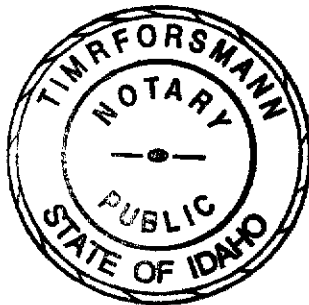
