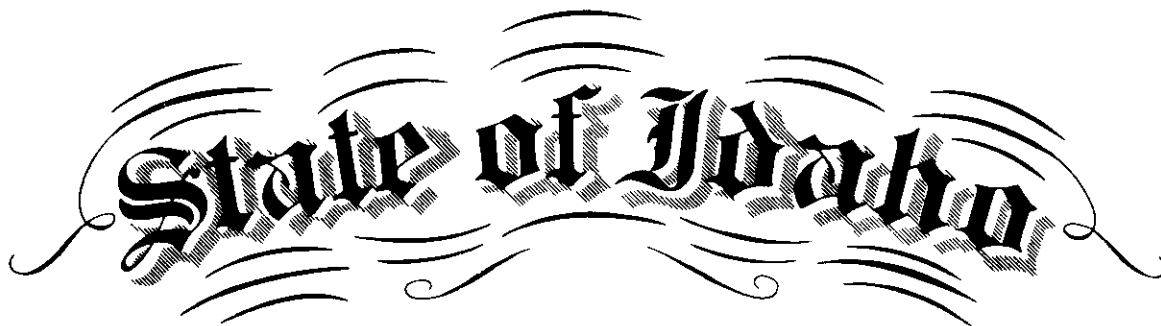




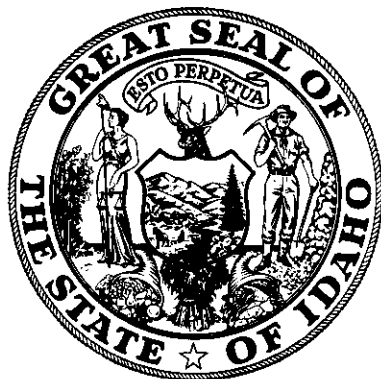
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
MAC WANN CUSTOM SPRAYING, INC.

WE, THE UNDERSIGNED, being two natural persons of full age, both of whom are natural citizens of the United States of America, do hereby voluntarily associate ourselves for the purpose of forming a corporation under Title 30, Chapter 1, Idaho Code, and other applicable laws of the State of Idaho.

FIRST

The name of the corporation is and shall be MAC WANN CUSTOM SPRAYING, INC.

SECOND

The purposes of the corporation are as follows:

To buy and sell, export, import, lease, exchange and generally deal in real and personal property of every class and description.

To engage in the business of purchasing, selling, distributing, leasing and otherwise dealing in fertilizers, pesticides and herbicides and engaging in the commercial applications of the same.

To manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, assign and transfer, or otherwise dispose of, to invest, trade, deal in and with goods, wares, and merchandise.

To act as agents for the purchase, sale, and handling of goods, wares, and merchandise of any and all types and

descriptions for the account of the corporation or as factor, agent, procurer, or otherwise for or on behalf of another.

To deal in stocks, bonds, or other securities, investments including the purchase and sale of the same, and in particular to purchase and sell, deal in or trade stocks issued by this corporation, and to acquire its own stock in such manner and upon such terms and conditions as the Board of Directors may determine to be in the best interests of the corporation.

To purchase, lease, mortgage, deal in or with all and every class and kind of real estate.

The purposes specified herein shall be construed both as purposes and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation; nor shall the expression of one thing be deemed to exclude another, although it be of like nature not expressed.

To likewise do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either along or in association with other corporations, firms or individuals, and to enter into,

make, perform, and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipal state, or government, or any subdivision or district thereof, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

THIRD

The duration of this corporation shall be perpetual.

FOURTH

The location and and post office address of the registered office of the corporation in the State of Idaho, is Route 4 Box 197B, Rupert, Idaho 83350, of which is physically located at 400 North 450 East, Minidoka County, Idaho. The initial registered agent for the corporation shall be Thurman "Mac" Wann who resides at the same address.

FIFTH

The total authorized number of shares is 1,000 having a no par value. The stock of the corporation is of but one class: Common. Shares are nonassessable by or on behalf of the corporation.

SIXTH

The names and post office address of the incorporators, and the number of shares of stock subscribed each, are as follows:

Said persons shall also constitute the initial Board of Directors who shall serve until the first meeting of incorporators.

SEVENTH

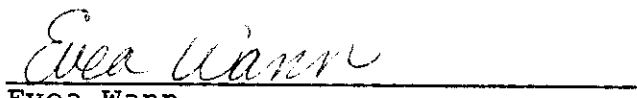
The power to repeal and amend By-Laws and adopt new By-Laws shall rest with the Board of Directors by a majority vote of the Directors.

The fiscal year of the corporation shall begin on January 1 and end on December 31 each year, but may be altered by the Board of Directors pursuant to the By-Laws.
