ARTICLES OF AMENDMENT

ARTICLES OF INCORPORATION

OF

FIRST BAPTIST CHURCH OF BLACKFOOT
(amended herein to the new name of
THE FIRST BAPTIST CHURCH, BLACKFOOT, IDAHO, INC.)

Pursuant to the provisions of Idaho Code §30-327, these are Articles of Amendment to the Articles of Incorporation of First Baptist Church of Blackfoot, executed September 29, 1908, and duly filed with the Secretary of State of the State of Idaho.

1. The name of the corporation is: First Baptist Church of Blackfoot (as part of this Articles of Amendment, the name of the corporation will be changed to: The First Baptist Church, Blackfoot, Idaho, Inc.).

2. The amended provisions are as follows:

A. The name of the corporation is hereby changed to: "The First Baptist Church, Blackfoot, Idaho, Inc.

B. The provision of the original Articles of Incorporation specifying that the term of incorporation shall be fifty (50) years is hereby amended to read:

"That the duration of this corporation shall be perpetual."

C. The following Article is added said Articles of Incorporation:

No part of the net earnings or the assets of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in

(including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under §501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.

D. The following Article is added said Articles of Incorporation:

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, distribute all of the assets of the corporation to The American Baptist Churches in the U.S.A.

Under no circumstances shall any of the property or assets of this corporation during the existence and/or upon the dissolution thereof go and be distributed to any officer, member or subsidiary of this corporation.

E. The following Article is added said Articles of Incorporation:

These Articles may be amended by ninety percent (90%) vote of the active membership of the church, said active membership being defined in the Bylaws of said corporation.

F. The following Article is added to said Articles of Incorporation:


The President of the corporation is the duly elected church moderator. The Directors are the Moderator, Church Clerk (corporate secretary), Chairman of the Board of Directors and Chairman of the Board of Deacons.

Except as modified herein, the original Articles of Incorporation dated September 29, 1908, are hereby reaffirmed.
