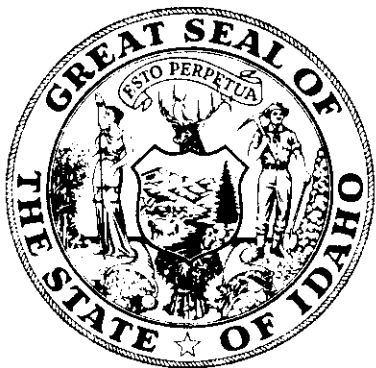

TO: The Secretary of State of the State of Idaho

THE UNDERSIGNED Corporation, IMAGE NATIONAL, INC., hereinafter designated the "Surviving Corporation", hereby executes in duplicate the following Articles of Merger of Signs, Inc., an Idaho corporation, which is a subsidiary corporation of Image National, Inc., in which Image National, Inc. owns all of the outstanding shares.

1. The Plan of Merger of said subsidiary corporation is as follows:

a. The name of the subsidiary corporation is SIGNS, INC. The name of the surviving corporation is IMAGE NATIONAL, INC.

b. The consideration for the surrender and extinguishment of the shares of the subsidiary corporation is the assumption by the surviving corporation of all assets and all liabilities of the subsidiary corporation, and no shares in the surviving corporation are to be issued or transferred by reason of this Merger.


