The merging entities intend this merger document to be filed with the Secretary of State for the state of Idaho.

1. AgraKey Solutions, LLC, is a limited liability company, formed and existing under the laws of the state of Idaho.
2. Dutch Brothers Enterprises, LLC is a limited liability company, formed and existing under the laws of the state of Idaho.

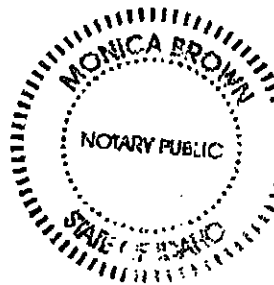

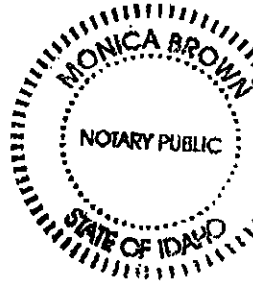

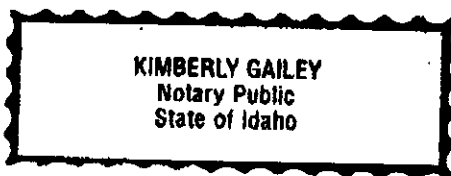
