

Articles of Incorporation of the Washoe Irrigating and Water Power Company.

Know all Men by these Presents: that We, the undersigned have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the Laws of the State of Idaho.

And we hereby Certify: First, that the name of said Corporation is the "Washoe Irrigating and Water Power Company, Limited".

Second; that the purposes for which it is formed, are to construct and maintain a Water Ditch on the Lower Payette River in Canyon County, State of Idaho., for Irrigation and other purposes.

Third; that the place where its principal business is to be transacted shall be at Washoe Bottom in Payette Precinct, in said Canyon County, Idaho.

Fourth; that the time for which it is to exist is Fifty years from and after the date of its Incorporation.

Fifth; that the number of its Directors shall be Five and that the names and residences of those who are appointed for the first year are:—

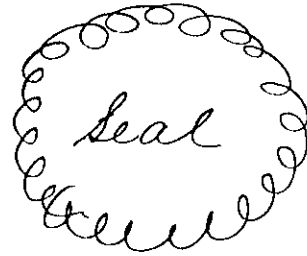
