We, the undersigned, desiring to form a corporation for profit, under the general corporation laws of the State of Idaho, do hereby make, subscribe, acknowledge, and file this certificate for that purposes as follows:

- FIRST: The name of the proposed corporation is J. E. BANKS SURVEYING COMPANY.
- SECOND: The principal office of the corporation is to be located at 1008 East Garden Avenue, Osburn, Idaho 83849.
- THIRD: James E. Banks, with offices located at 1008 East Garden Avenue, Osburn, Idaho 83849 is the registered agent on whom process may be served.
- FOURTH: The purposes for which the corporation is to be formed are:
are: 1. To provide surveying services to any and all including Public, Corporation, Government and any others that may require surveying to be performed.
2.
