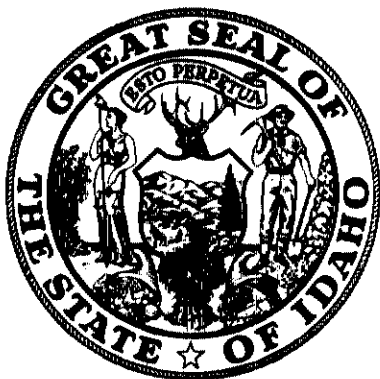

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act adopts the following articles of incorporation:

ARTICLE ONE

Corporate Name.

The name of the corporation is J & R CARRIERS INCORPORATED.

ARTICLE TWO

Purpose.

The purposes of the corporation is to carry dairy products, and all other types of freight for hire; to receive and load all varieties of commercial freight on board highway motor vehicles; to transport such freight to various destinations in the State of Idaho or throughout the United States; and to buy sell, and otherwise deal in and with tractors and trailers, and all other types of trucks suitable for commercial trucking, and to maintain and repair the same. To engage in any or all lawful business for which corporations

may be organized under the Idaho Business Corporation Act.

### ARTICLE THREE

#### Duration.

The period of duration of the corporation is perpetual.

### ARTICLE FOUR

#### Registered Office and Agent.

The address of the corporation's initial registered office in the State of Idaho is 754 South 50 West, Victor, Idaho 83455. The name of the corporation's initial registered agent at such address is Jan Carpenter.

### ARTICLE FIVE

#### Stock

This corporation is authorized to issue only one class of stock shall be held of record by not more than 20 persons . Stock shall be issued and transferable only to natural persons who are not non resident aliens.

The total authorized number of stock is 100,000 shares all without par value.


