The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act adopts the following articles of incorporation:

#### ARTICLE ONE

### Corporate Name.

The name of the corporation is J & R CARRIERS INCORPORATED.

# ARTICLE TW

#### Purpose.

The purposes of the corporation is to carry dairy products, and all other types of freight for hire; to receive and load all varieties of commercial freight on board highway motor, vehicles; to transport such freight to various destinations in the State of Idaho or throughout the United States; and to buy sell, and otherwise deal in and with tractors and trailers, and all other types of trucks suitable for commercial trucking, and to maintain and repair the same. To engage in any or all lawful business for which corporations

#### Duration.

The period of duration of the corporation is perpetual.
