ARTICLES OF INCORPORATION

OF

PANHANDLE TRAIL RIDERS ASSOCIATION, INC.

The undersigned, acting as an incorporator of a corporation under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Panhandle Trail Riders Association, Inc., a non-profit corporation, pursuant to Idaho Code 30-301, et seq.

SECOND: The purpose or purposes for which the corporation is organized are:

The transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act, including, but not limited to, conduct as a recreational off-road vehicle association.

THIRD: The corporation shall have members who shall be subject to qualification and voting as set forth in the bylaws of the corporation. The management of the affairs of the corporation shall be vested in the Board of Directors.

FOURTH: The address of the initial registered office of the corporation is Woodward L. Clouse, 303 E. 1st Ave, Post Falls, Idaho 83854, and the name of its initial registered agent at such address is Woodward L. Clouse.

FIFTH: The number of directors constituting the initial Board of Directors of the corporation is seven (7) and the
