I, the undersigned, natural person of the age of twenty-one years or more, acting as incorporator of the corporation under Wyoming Business Corporation Act adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is MOSCUE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: The corporation shall have unlimited power to engage in and do lawful acts concerning any and all lawful business for which said corporation may be organized under Section 26(c), Wyoming Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 45,000 of common stock with no par value.

FIFTH: The corporation will not commence business until at least Five Hundred (\$500.00) Dollars has been received by it as consideration for the issuance of shares.



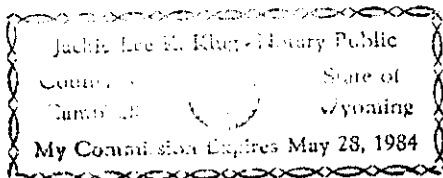
