The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

Name. The name of the corporation is P.L.C., INC.

ARTICLE TWO

Purposes. The purpose of the corporation is to engage in business pursuits deemed advantageous or beneficial to the corporation. Specifically, the corporation will purchase and/or lease fire fighting equipment, including, but not limited to, a water tender, which will be operated and managed by the corporation and which will be available for contract hire. The corporation may further maintain, by ownership or leasehold interest, logging and/or grain hauling trucks and shop facilities for the conduct of business purposes. The corporation may further conduct such other business as is usual, proper and necessary in such business enterprise without limitation. The corporation may further engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE

Duration. The period of duration of this corporation is perpetual.

ARTICLE FOUR

Registered Office and Registered Agent. The address of the corporation's initial registered office in the State of Idaho is Flat Creek, Route 4, Box 92, City of St. Maries, County of Benewah, State of Idaho Idaho 83861. The name of the corporation's initial registered agent at such address is Beverly F. Thomason.

ARTICLE FIVE

Stock. The total authorized number of par value shares of stock is 10,000. The aggregate par value of the total authorized number of par value shares is one million dollars.

ARTICLE SIX

Transfer of Stock. In case a stockholder desires to sell his shares of stock, he must first offer them for sale to the remaining stockholders, it being the intention to give them a preference in this purchase of such shares, and any attempted sale in violation of this provision is null and void.

A stockholder desiring to sell his stock shall file notice in writing of his intention with the secretary of the corporation, stating the terms of sale, and unless his terms

are accepted by any or all other stockholders within thirty (30) days thereafter, they shall be deemed to have waived their privilege of purchasing and he will be at liberty to sell to anyone else.

ARTICLE SEVEN

Directors. The number of directors constituting the initial Board of Directors is five (5), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualify are:
