The undersigned, a majority of whom are citizens of the United States, desiring to form a non-profit corporation under the Idaho Non-Profit Corporation Act, do hereby certify;

- 1. That the name of the corporation shall be "Cowboy Poets of Idaho,"
 Inc."
- 2. The initial registered office of the corporation shall be: Lisa M. Volkman, 3445 So. Linder Rd., Meridian, Idaho 83642
- 3. The duration of the corporation shall be perpetual.

- 4. The purpose or purposes for which the corporation is organized are; exclusively charitable, educational and civic, including but not limited to the following: a)to form an association of poets and traditional artists; b) to present a collective voice to the public; c) to preserve our heritage; d) to establish a registry of cowboy poets and traditional artists; e) to schedule periodic forums to present traditional art forms.
- 5. The corporation shall have one class of membership, the qualifications and rights of the members shall be set forth in the bylaws of the corporation.

7. No part of the net earnings of the corporation shall inure to the henefit of, or he distributable to it's members, trustees, officers or other private persons, except that the corporation may pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles. We substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, nor shall it participate in or intervene in any political campaign on behalf of any
