Article 2: The purpose for which the corporation is organized is:

Purpose:

The corporation is organized exclusively for charitable, benevolent, educational, and religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code (or corresponding provision of any future U.S. IRS Code) in order to establish a culture where the value and dignity of every human being is honored from conception to a natural death, so that every voice has the opportunity to glorify the Lord Jesus Christ and to speak Life to others.

The corporation will solicit, receive, and maintain funds to use in furtherance of the above purpose in accordance with its mission and vision set out below.

Among other things, this includes the fact that no part of the funds received or earnings of this corporation shall inure to the benefit of any private member or individual except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of its purpose, mission, & vision.

In addition, no substantial part of its activities will be to carry on propaganda, or otherwise attempt to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Mission:

Acknowledging God as our Creator, and human beings as his unique image-bearers, we seek to use our voices to worship our heavenly Father by means of creative/performance arts and communication avenues such as writing, singing, speaking, painting, drama, and dance in order to proclaim the gospel of Jesus Christ and bring Life to men, women and children everywhere.

Vision:

At Voice for Life, we envision a culture where the value and dignity of every human being is honored from conception to a natural death, so that every voice has the opportunity to glorify the Lord Jesus Christ and to speak Life to others.

Case Statement:

In keeping with biblical principles, we will use our voices and our talents to promote the good news of Jesus Christ and the love of God for every human being. We are committed to pursuing excellence in the use of creative communication in order to draw people to Christ, who frees us from sin and gives us courageous compassion for others. The Bible and the Holy Spirit are the foundation of this ministry for the purpose of:

- Proclaiming the gospel of Jesus Christ through creative arts and communication
- Speaking up for those without a voice (the marginalized, oppressed, and most vulnerable)
- Empowering Christians to use their voices to speak Life into their families, churches, and communities

Scriptural Foundation:

- Deuteronomy 30:19-20a (ESV) "I have set before you life and death, blessing and curse. Therefore choose life, that you and your offspring may live, loving the LORD your God, obeying his voice and holding fast to him, for he is your life and length of days..."
- Proverbs 18:21 (ESV) "Death and life are in the power of the tongue, and those who love it will eat its fruits."
- Isaiah 40:3 (NIV) "A voice of one calling: 'In the wilderness prepare the way for the LORD' make straight in the desert a highway for our God."

Article 8:
