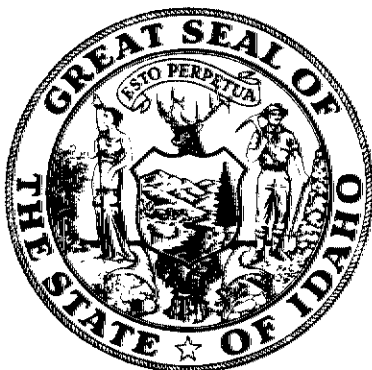



Title 30 of the Idaho Nonprofit Corporation Act, Idaho Code.

- To: 1) Articles of Incorporation
2) Constitution and by-laws
- A) At: First Christian Church of Lewiston, Incorporated
