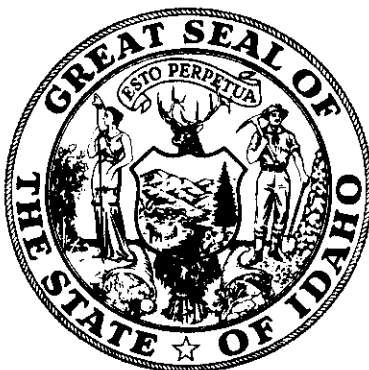

SECRETARY OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE 1: The name of the corporation is  
DOUBLE H INC.

ARTICLE 2: The period of its duration is perpetual.

ARTICLE 3: The purpose or purposes for which the corporation is organized:

(a) To acquire by purchase, lease or otherwise and improve and develop real property. To erect buildings, private or public, of all kinds, and to sell or rent the same. To buy, sell, mortgage, exchange, lease, let, hold for investment or otherwise, use, and operate real estate of all kinds, improved or unimproved, and any right or interest therein.

(b) To enter into partnership agreements and joint ventures with any person, firm, association, or corporation.

(c) To transact any and all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE 4: The aggregate number of shares which the corporation shall have authority to issue is five hundred (500), all of which shall be without par value. The Board of Directors may from time to time fix the consideration for which such shares shall be issued and sold. The capital stock when fully paid shall be nonassessable and shall be of one class, all of which shall be voting. Voting of stock may be cumulative.


