## ARTICLES OF INCORPORATION

OF

THE OLA PARENT-TEACHER ORGANIZATION, INC.

THE UNDERSIGNED, acting as incorporators of a non-profit corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is The Ola Parent-Teacher Organization, Inc.

SECOND: This corporation is a non-profit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The purpose or purposes for which the corporation is formed are:

- a. To promote the welfare of children in school and community.
- b. To bring into closer relation the home and the school, that parents and teachers may cooperate intelligently in the training of the child.
- c. To develop between educators and the general public such united efforts as will secure for every child the highest advantages in physical, mental, social, and spiritual education.

FIFTH: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in distributions in furtherance of the purposes set forth in paragraph FOURTH above.

SIXTH: This corporation shall have members who shall elect the officers of the corpation.

SEVENTH: The management of the affairs of the corporation shall be vested in the corporation's officers subject to advice and consent of the membership.

EIGHTH: The street address of this corporation shall be 312 East Main Street, Emmett, Idaho 83617, and the name of its initial registered agent is E. C. ROOD.
