KNOW ALL MEN BY THESE PRESENTS: That the undersigned, an adult citizen of the United States and resident of the State of Idaho, does hereby establish JC & Associates, Inc., as a corporation under the provisions of Chapter 1, Title 30, Idaho Code, and in furtherance of said purpose does hereby certify:

- 1. Name. The name of the Corporation is JC & Associates, Inc.
- 2. <u>Purposes</u>. The Corporation is established for the purpose of conducting any and all business that may be conducted by or on behalf of corporations in the State of Idaho.
- 3. <u>Duration</u>. The Corporation shall have perpetual existence.
- 4. <u>Authorized shares</u>. The aggregate number of shares which the Corporation shall have authority to issue is 10,000 shares of the par value of \$1.00 each, all of one of class, which shall be designated common stock.
