ARTICLES OF INCORPORATION

OF

UPPER VALLEY BIBLE CHURCH, INC. OF ST. ANTHONY, IDAHO

(Page 1 of 2)

We, the undersigned residents of the State of Idaho, being twenty-one years or more of age, do hereby associate ourselves together for the purpose of forming a nonprofit corporation (a church) under the statutes of the State of Idaho.

ARTICLE I

The name of this corporation is Upper Valley Bible Church, INC., of St. Anthony, Idaho.

ARTICLE II

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are: To promote worship, sharing of the gospel message, spiritual growth and ministry of needs, and to foster a Christlike life and obedience to God's commands; through prayer, fellowship and instruction in the Word (Bible).

ARTICLE IV

The address of the registered office of the corporation is County of Fremont, State of Idaho, and the name of the registered agent at such address is Allan Brug, 755 South River Rd. St. Anthony, Idaho, 83445.

ARTICLE V

The corporation shall be non-stock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE VI

The corporation shall have one class of member, and the qualifications shall be as follows:

1. Those persons who have accepted Jesus Christ as their Savior and Lord,
2. Those who have been baptized by believer's baptism,
3. Those who voluntarily have requested such membership.
4. The candidate for membership shall further meet the conditions prescribed in the Upper Valley Bible Church, INC. of St. Anthony, Idaho, bylaws.

ARTICLE VII

(Page 2 of 2)

The business and affairs of the corporation shall be conducted by the Trustees (Elders) consisting of not less than three, who shall be appointed by the existing Elders as provided in the Bylaws. Herein for the rest of this document they shall be called "Elders".

ARTICLE VIII

Regular and special meetings of the Elders of this corporation shall be held at such times and places and on such notice as provided in the Bylaws.

ARTICLE IX

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets and real property shall return to Calvary Baptist Church of Idaho Falls, Idaho.

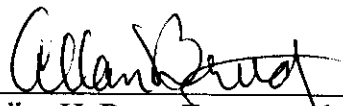
