

Articles of Incorporation

As set forth in section 30-3-17 of the Idaho Nonprofit Corporation Act.

a.) New Life Ministries, Inc.

b.) The purpose/purposes of New Life Ministries, Inc., is as follows:

- 1.) To preach the Gospel of Jesus Christ.
- 2.) The teaching and training of adult/youth in Biblical doctrine and principles.
- 3.) To operate Day School/Day Care for the purpose of instruction and training.
- 4.) To fund and send out missionaries, both home and abroad, for the express purpose of evangelism.
- 5.) To function in both the research of and instruction in Biblical Creationism and other related topics.
- 6.) To actively be involved in the dispensing of charities, charitable works, alms, ect., for those in need.
- 7.) To acquire goods, properties, finances, ect., through the giving and receiving of offering and donations, fund-raising, and other such means to facilitate the purpose/intent of New Life ministries in the aforementioned.
