CERTIFICATE OF INCORPORATION

I, ~~JOHN H. MASTERS~~ ^{IRA H. MASTERS}, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of **HI-WAY CHAPEL OF McCALL, IDAHO, INC.**

was filed in the office of the Secretary of State on the **13th** day of **May** A. D. One Thousand Nine Hundred **Fifty-three** and is duly recorded on Film No. **80** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 29-103, 29-1101 and 29-1102, Idaho Code, Annotated.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **McCall** in the County of **Valley**, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION

OF

HI-WAY CHAPEL OF McCALL, IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age and citizens of the United States, having associated ourselves together for the purpose of forming a religious corporation under and by virtue of the laws of the State of Idaho, do hereby certify as follows:

I.

That the name of the corporation is and shall be:

HI-WAY CHAPEL OF McCALL, IDAHO, INC.

II.

The duration of this corporation is from May, 1953 and is to have perpetual existence.

III.

The location and principal place of business of this corporation shall be in the Village of McCall, County of Valley, State of Idaho.

IV.

This corporation shall be interdenominational.

V.

The purpose for which said corporation is organized and incorporated is and shall be:

(1) To establish and maintain a place of Divine Worship.

- (2) The study and practice of Godliness as set forth in the Sacred Scriptures of the Old and New Testaments.
- (3) The exercise of a spiritual watch care over each other, on the part of the membership, and a building one and another up in the Christian Faith.
- (4) To carry out the great commission of our Lord in preaching and publishing the gospel to the people of its ministry, to be accomplished by establishing and promoting Sunday Schools, missions and all other means deemed practical.
- (5) To purchase, lease, acquire, accept, hold and manage by deed, grant, will, gift, bequest, trust or otherwise all manner and kinds of property whether real, personal or mixed to be used for and carry out the purposes for which said corporation was organized.
- (6) To borrow, sell, mortgage, issue its notes, bonds, debentures and other evidences of indebtedness and to do any and every act or thing germane to any of the aforesaid purposes.
- (7) Pecuniary profit shall not be the object or purpose of this corporation.

VI.

The estimated value of the property and money possessed by this corporation at the time of executing these articles of incorporation within the State of Idaho and vested in said corporation is Seven Thousand Five Hundred Dollars (\$7,500.00). The sources of revenue or income of this corporation is and will be pledges, gifts, bequests, offerings, contributions and money derived from the property of the corporation.

VII.

Two publications were made of notice of incorporation and election of directors (also known as trustees) of Hi-Way Chapel of McCall, Idaho. Said notices were placed in the Payette Lakes Star, newspaper of general circulation for McCall, county of Valley, Idaho, on the twenty-third day of April, 1953 and on the thirtieth day of April, 1953, two weeks prior to the scheduled meeting of its members, by said newspaper, the Payette Lakes Star.

For two weeks prior to meeting, a notice setting forth like information was posted in a conspicuous place on the building where election of directors and plans for organization were made.

Said meeting was duly held on Friday the 1st day of May, 1953, with majority of members present, the Articles of Incorporation were read and adopted. Election of directors were held. The following directors were elected:
