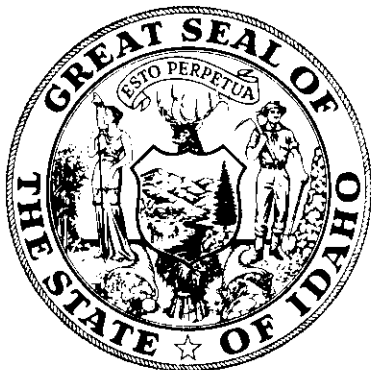

AMENDMENT OF THE ARTICLES OF INCORPORATION

WHEREAS as special meeting of the corporation of Cochrane, Goffinet & Clack, Chartered was held at 125 1st Street, Orofino, State of Idaho, on the 21st day of December, 1983, at 2:00 P.M., with directors and all shareholders to-wit: John Goffinet and Steve Clack being present. The shareholders consisting of 254 shares of common stock were entitled to said amendment and all shares of each class voted for amendment as set forth herein.

The amendment authorize that the officers changed the name of this professional corporation to Goffinet & Clack, Chartered, due to the resignation of Shirley Cochrane and the liquidation of all her shares in said corporation.
