

Article III  
PURPOSE AND POWERS OF THE CORPORATION

The Corporation is a nonprofit benefit corporation and is not organized for the private gain of any individual or entity.

The Corporation is organized under the Idaho Nonprofit Corporation Act for the purpose of promoting and advancing education in the public schools in the Kuna Joint School District No. 3, and furthering the opportunities of worthy students to attend postsecondary education and such other educational activities as the Board of Directors may define from time to time, consistent with Internal Revenue Code Section 501(c)(3).

The internal affairs of the Corporation shall be governed by the duly adopted Bylaws, which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.

No part of the net earnings of the Corporation shall be distributed to its Directors.

The specific primary purposes for which the Corporation is formed are as follows:

1. To utilize the earned interest or other earnings of the Corporation's assets to fund, benefit, and provide resources to teachers in the Kuna Joint School District No. 3 who wish to enhance educational opportunities in their classrooms.
2. To utilize the earned interest or other earnings of the Corporation's assets to fund, benefit, and enhance the opportunities of students in the Kuna Joint School District No. 3, as determined by the Board of Directors or its designee, who graduate from the Kuna School District in accordance with the laws of the State of Idaho.
3. To do, and engage in, any and all lawful activities that may be incidental or reasonably necessary to any of the foregoing purposes, and to have and exercise all other powers and authority now or hereafter conferred upon a not-for-profit organization under the laws of the State of Idaho and Internal Revenue Code Section 501(c)(3).
