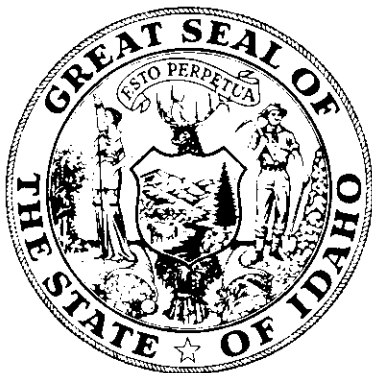

**CHANGE OF NAME**  
**ACCORDING TO THE CONSTITUTION AND BY-LAWS OF**  
**VALLEY ASSEMBLY OF GOD, INC.**  
**HC 01, BOX 16**  
**PINEHURST, IDAHO 83850**

At a regular and duly called meeting of the board members of Valley Assembly of God, Inc. on April 17, Thursday, 1986 did unanimously approve the change of name of Valley Assembly of God, Inc. to New Hope Assembly of God, Inc. The process then did proceed to a membership vote according to the pattern set forth by the amendment procedure of the Constitution of Valley Assembly of God, Inc.

The date of May 11, 1986, at 12-noon was set for a special called business meeting of the membership for a vote on the change of name. Procedure according to the Constitution of Valley Assembly of God, Inc. was adhered to of which **Article XI. Amendments** is hereby stated:

"This Constitution may be amended or changed by a two-thirds majority vote of the members present and voting at any regular or special business meeting provided due notice has been posted in writing of such proposed change at least two weeks prior to the meeting and announcement has been made at two Sundays preceding the time of such meeting."

Attached to this sheet of paper is the notice and letter of intent to the membership of the Church announcing the purpose and date of the special business meeting.

The date and purpose of the special meeting was announced more than two Sundays prior to the meeting.

On May 11, 1986, at approximately 12-noon, a meeting of the membership convened with a quorum present and with greater than a two-thirds majority vote did adopt the amendment to delete the word, "**Valley**" from the name of "Valley Assembly of God, Inc." and insert the words, "**New Hope**" thus changing the name of the Church to "**New Hope Assembly of God, Inc.**"

The amended Constitution shall read:

**Article I. Name and Location**

"The name of the Church shall be New Hope Assembly of God, Inc. which is located at 1008 S. Division in the city of Pinehurst, County of Shoshone, in the State of Idaho. The mailing address is, HC 01, Box 16, Pinehurst, Idaho 83850."

This shall not alter or change any portion of the Constitution and By-Laws except the afore mentioned above, Article I. Name and Location.
