ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, ACTING AS THE INCORPORATOR OF A CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO, PURSUANT TO THE IDAHO BUSINESS CORPORATION ACT, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION:
