WHEREAS, EDWARDS & HOWARD, INC. was organized under and by virtue of the laws of the State of Idaho on the 12th day of November, 1973, and

WHEREAS, said Articles of Incorporation were duly and regularly filed in the Office of the Secretary of State on the 15th day of November, 1973, and

WHEREAS, on the 15th day of December, 1978, Article I of the Articles of Incorporation of said corporation was amended to change the name of said corporation from EDWARDS & HOWARD, INC., to EDWARDS, HOWARD & MARTENS, INC.

NOW, THEREFORE, we, the undersigned, CHARLES D.

HOWARD and CARL V. EDWARDS, President and Secretary, respectively of EDWARDS & HOWARD, INC., a corporation organized and existing under and by virtue of the laws of the State of Idaho, DO HEREBY CERTIFY as follows:

That the said Charles D. Howard is President of the said corporation, and the said Carl V. Edwards is Secretary of said corporation.

That at a special meeting of the stockholders of said corporation held December 15, 1978, at which all stockholders were present, the stockholders unanimously passed and adopted a resolution amending the ARticles of Incorporation of said corporation, which resolution is as follows:

"Whereas, the stockholders of EDWARDS & HOWARD, INC. desire to amend the Articles of Incorporation by changing the name of said corporation,

NOW, THEREFORE, be it resolved that the Articles of Incorporation be, and they are hereby amended by striking therefrom Article I and adding thereto the following new Article I so that the Articles of Incorporation, as amended, shall read as follows:

## ARTICLE I.

The name of this corporation is EDWARDS, HOWARD & MARTENS, INC.'

Resolved further that said amendment is hereby adopted and approved."
