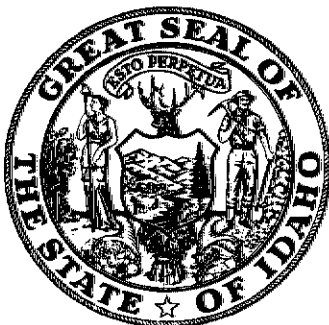

**ARTICLES OF INCORPORATION**

**ARTICLE I.**

The name of the Corporation shall be McArthur Development Company.

**ARTICLE II.**

The period of duration shall be perpetual.

**ARTICLE III.**

The purposes for which the Corporation is organized shall be conducting the business of development and sale of real property, and shall include the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.
