Know All Men By These Presents, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho; and we hereby certify:

First-

That the name of said corporation is The Young Men's Christian Association of Boise, Idaho

Second.

That the purposes for which it is formed are to promote the spiritual, intellectual, social and physical welfare of young men.

Third.

That the place where its principal ~~XXXXXXX~~ business is to be Boise, Ada County, Idaho.

Fourth.

That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth.

That the number of its directors shall be eleven; and the names and residences of those who were elected for the first year are as set forth in the following certificate.
