ARTICLES OF INCORPORATION

OF

We, whose names are hereunto subscribed, all of whom are citizens of the United States of America and bona fide residents of the State of Idaho, and each of us being of full legal age, do under pursuant to the general corporation laws of the State of Idaho, associate ourselves together for the purpose of becoming a body corporate, and do now declare these are the Articles of Incorporation of STEADMAN IMPLEMENT CO., a corporation.

ARTICLE I

The name of this corporation shall be:

STEADMAN IMPLEMENT CO.,

ARTICLE II

The purposes for this corporation is formed are:

- a. To engage in, to carry on, and to conduct the retail sale of farm machinery, heavy equipment, hardware, and other related merchandise, and to carry on a business of and for the repairing of all types of heavy equipment and machinery and other related mechanical devices.
- b. To do each and everything necessary and essential for the accomplishment of the purposes of the corporation above set forth.

### ARTICLE III

The principal place of business of said corporation shall be 53 S. 1 W., Preston, Franklin County, Idaho.

### ARTICLE IV

The term of this corporation shall be perpetual.

### ARTICLE V

The corporate power and business shall be exercised and controlled by a board of five directors.

### ARTICLE VI



