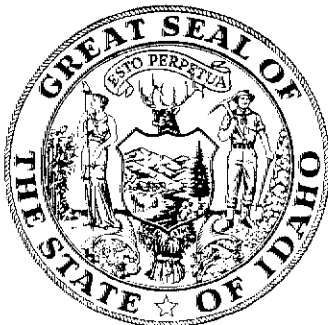

depose and say:

I.

That the said ROBERT E. LYONS is the President, and the said JOAN E. LYONS is the Secretary of LYONS PLUMBING, INC., a corporation which is, and at all times herein mentioned has been, a corporation duly organized and existing under and by virtue of the laws of the State of Idaho. They are the only officers, directors and shareholders of the corporation.

That the shareholders of said corporation met in special meeting on the 20th day of August, 1996, at Boise, Idaho, pursuant to call and waiver of notice of said meeting and, after being advised of purposes thereof and of a resolution proposed by the Board of Directors, as provided by the laws of the State of Idaho and the By-laws of said corporation, and did regularly vote, pass and unanimously adopt, the following resolution, to-wit:

VI.

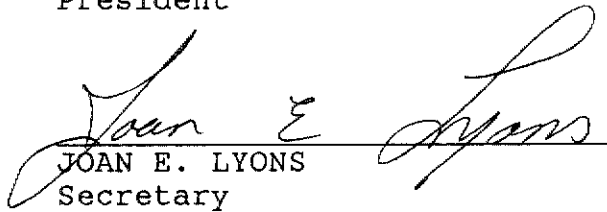
