ARTICLES OF INCORPORATION  
OF THE  
SALMON CITY ELECTRIC LIGHT AND POWER COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

AND WE HEREBY CERTIFY: First, That the name of said Corporation is The Salmon City Electric Light and Power Company.

Second.

That the purpose for which it is formed are furnishing to and supplying the inhabitants and town of Salmon City, Idaho, and vicinity with Electric Lights and Power.

Third.

That the place where its principal business is to be transacted shall be the town of Salmon City, County of Lemhi, State of Idaho.

Fourth.

That the term for which it is to exist is Fifty Years from and after the date of its incorporation.

Fifth.

That the number of its directors shall be Six, and the names and residences of those who are appointed for the first year are:
