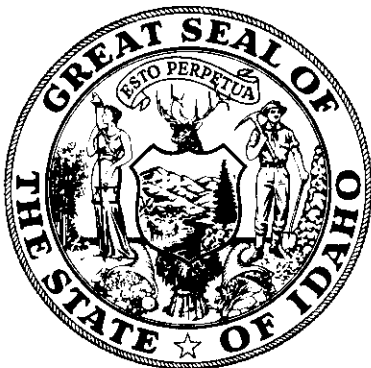

ARTICLES OF INCORPORATION  
of

Spirit Lake Faith Baptist Church , Incorporated

We, the undersigned, residents of the State of Idaho, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the laws of the State of Idaho.

ARTICLE ONE.

The named of the Corporation shall be Faith Baptist Church.

ARTICLE TWO.

The Post Office address of the Corporation's principle office is : Star Route Box 252, Spirit Lake, Idaho 83869

ARTICLE THREE.

The period of duration of this nonprofit Corporation shall be perpetual.

ARTICLE FOUR.

The business and purpose of this Corporation shall be to conduct a baptist church, promoting the worship of our God, edifying believers, teaching to hold counsel of God, administering the ordinances of biblical discipline, seeking to win the loss to Christ through personal witnessing and preaching of the Gospel, carrying a vigorous missionary pro-

gram around the world, establihsing other baptist churches, defending the faith, and maintaining a good testimony for Christ in our community for Godliness and good works.

ARTICLE FIVE.

The Corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE SIX.

The number of Directors constituting the initial Board of Directors of the Corporation is five, and the names and addresses of persons who are to serve as initial Directors are as follows:
