TEARIM CORPORATION

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation as required under Title 30 of the Idaho Code, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is TEARIM Corporation.

SECOND: The period of its duration is perpetual or until otherwise dissolved according to law.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To own, maintain and operate restaurants and cocktail lounges.
- (b) To do any and all things which a corporation may legally do not inconsistent herewith even though not specifically mentioned herein as the Board of Directors of said corporation may determine from time to time.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares at \$1.00 par value.

FIFTH: The corporation will not commence business until consideration of the value of at least \$1,000.00 has been received for the issuance of shares.

SIXTH: Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: None.
